O R D E R

On July 26, 2007, the Commission entered an Order directing the parties to this case, Brandenburg Telephone Company ("Brandenburg Telephone") and Global Crossing Telecommunications, Inc. ("Global Crossing"), to inform the Commission, within 10 days of the date of the Order, of the status of settlement negotiations between the two parties. The Order also required Global Crossing, if no settlement was reached, to file an answer to Brandenburg Telephone's complaint within 15 days of the date of the Order. The due dates were August 6, 2007 and August 15, 2007, respectively.

On August 3, 2007, the parties filed a joint motion for an extension of time in which to file their status reports and, if necessary, Global Crossing's answer. The parties proposed the status reports be due no later than August 15, 2007, and Global Crossing's answer be filed no later than August 24, 2007.

The Commission, in order to facilitate settlement negotiations, finds that the parties' motion should be granted.

IT IS THEREFORE ORDERED that:


1. Individual or joint settlement status reports shall be filed with the Commission no later than August 15, 2007.

2. In the event no settlement is reached, Global Crossing shall file its answer to Brandenburg Telephone's complaint no later than August 24, 2007.
