

**DUO COUNTY TELEPHONE COOPERATIVE'S FILING  
FOR EXEMPTION FROM THE MANDATORY POOLING REQUIREMENT  
IN THE COMMISSION'S ORDER DATED JUNE 15, 2007**

On June 15, 2007, the Commission adopted an Order in the above-referenced proceeding ("Order") in which it stated that rural telephone companies and Tier III Commercial Mobile Radio Service providers that satisfied certain "exemption requirements" set forth by the Federal Communications Commission ("FCC") would continue to be exempt from mandatory pooling as implemented in the 270 NPA so long as they notify the Commission.<sup>1</sup> Pursuant to this Order, Duo County Telephone Cooperative (the "Company"), a rural telephone company, hereby notifies the Commission that the Company is exempt from the mandatory pooling requirement. As required in the Order, the Company provides the following list of each rate center in the 270 NPA to remain exempt and a description of the specific qualification(s) met for each exemption.

**Rate Center (NPA-NXX)**

**Description**

270-343 – Jamestown

The Company has not received a specific request for the provision of LNP from another carrier for this rate center and is the only service provider receiving numbering resources in this rate center.

270-378/379 – Fairplay

The Company has not received a specific request for the provision of LNP from another carrier for this rate center.

270-430/433 – Burkesville Rural

The Company is the only service provider receiving numbering resources in this rate center.


<sup>1</sup> The Commission noted that the FCC exempted these carriers from mandatory pooling requirements if the carrier had not received a specific request for the provision of Local Number Portability ("LNP") from another carrier or if the carrier was the only service provider receiving numbering resources in a given rate center.
