Dear Ms O'Donnell:

On June 15, 2007, the Kentucky Public Service Commission ("Commission") issued an Order in this docket revising the implementation of the new 364 area code in western Kentucky. Further, the Commission sought comments at that time from "all carriers within the 270 NPA to provide comments…regarding the implementation of mandatory [number] pooling" approved by the FCC on May 31, 2007.

Windstream currently is pooling numbering resources on a voluntary basis in the 270 area code and has been since September 2005. This voluntary pooling in the 270 area code has not been a burden to Windstream. In fact, by initiating voluntary number pooling, Windstream has avoided issues with software provisioning and installation that may hamper implementation of mandatory pooling at a later date.

Windstream strives to be a good steward of its numbering resources and will continue to work with the Commission to meet public policy initiatives with respect to mandatory pooling, permissive dialing for the new 364 area code and mandatory dialing when deemed appropriate. Windstream further believes that the Commission's revision of timelines in this docket will
