
**CORRECTED MOTION OF CAK FOR EXTENSION OF

Comes Community Action Kentucky, Inc. (CAK), formerly known as Kentucky Association for Community Action, Inc. (KACA), by and through counsel, and hereby corrects the Motion CAK erroneously filed in Case No. 2005-00341 for an extension of time until March 31, 2009 within which to file a program evaluation with the Commission for the Home Energy Assistance (HEA) Program implemented by Kentucky Power Company, in conjunction with CAK, as part of the settlement agreement reached in this matter. The Motion should have been filed in this matter but was erroneously filed in the general rate case of Kentucky Power Company, Case No. 2005-00341.

The agreement in this matter calls for the evaluation to be filed by the end of February, 2009; however, due to other demands brought about by the implementation of the statewide LIHEAP program, CAK will not be able to file the evaluation within the time contemplated by the agreement.
