COMMENTS OF LOUISVILLE GAS AND ELECTRIC COMPANY TO INTRA-AGENCY MEMORANDUM AND FILING OF ADDITIONAL CUSTOMER INFORMATION

In connection with the Intra-Agency Memorandum filed by the Staff of the Kentucky Public Service Commission ("Commission") on December 12, 2006 in the above-captioned proceeding, Louisville Gas and Electric Company ("LG&E") respectfully submits the following comments:

In the list of persons who attended the December 1, 2006 Informal Conference, 1. Katrina Clark is incorrectly listed as "Patricia Clark."

2. With regard to the statement that "there are no records available that verify the actual electric and/or gas usage for the unpaid amounts in question," LG&E states that, while the actual billing records of the customer have aged off of LG&E's customer information system, LG&E has retained copies of Mr. McKeehan's service order history and miscellaneous action information which accurately depict the previously billed, but unpaid amounts owed for service rendered at 4105 Southern Parkway and 319 M Street, Apartments 1F and 2F. Copies of the service order history and miscellaneous action information for the above-referenced addresses, as well as for 2907 Arlington Road, are attached hereto as requested during the informal conference.

3. Finally, LG&E is exploring possible settlement options and has left a message for Mr. McKeehan to discuss these options. LG&E will notify the Commission if the parties are unable to reach a mutually- acceptable resolution to the matter.
