ORDER

On September 11, 2006, Kenergy Corp. ("Kenergy") filed with the Commission a proposed amendment to its "Agreement for Tier 3 Energy Service" with Big Rivers Electric Corporation ("Big Rivers"). This amendment reduces the amount of Block A Energy that Kenergy must purchase from Big Rivers for the use of Alcan Primary Products Corporation ("Alcan") from 17 megawatts to 12 megawatts. Alcan has consented to this proposed amendment. Kenergy requests that the notice period required pursuant to KRS 278.180 be reduced to 20 days to permit the proposed amendment to become effective on October 1, 2006.

Having reviewed the terms of the proposed amendment and being otherwise sufficiently advised, the Commission finds that good cause exists to accept the proposed amendment and to reduce, pursuant to KRS 278.180(2), the required notice period to permit the proposed amendment to become effective on October 1, 2006.

IT IS THEREFORE ORDERED that:

1. The time in which Kenergy must provide notice to the Commission of the proposed contract amendment is reduced to 20 days.

2. Kenergy's proposed amendment to the "Agreement for Tier 3 Energy Service" with Big Rivers is accepted and effective as of October 1, 2006.
