
Dear Ms. Grider:

I have been here all my life and my family farm has been here over 100 years, and I have never heard of the historic property they mention in this ad. What is the NATIONAL PROGRAMMATIC AGREEMENT OF MARCH 7, 2005 under the NATIONAL HISTORIC PRESERVATION ACT OF 1966 ?????????? And what does this have to do with putting up a microwave cellular tower ?????????? I thought you said in your August 31, 2006 letter, the alternative sight was going to be 200 ft. from Andrew Antle residence on Damron Creek Spur Road. What does this mean????????? Again, I raise the question of who are these partnerships that keep popping up here and causing people problems.
