September 1, 2006 Informal Conference

An informal conference was held in this matter on Friday, December 15, 2006, commencing at 10:00 a.m., for the purpose of obtaining an update of the financial condition of East Kentucky Power Cooperative, Inc. ("EKPC"). A list of those persons attending either in person or telephonically is attached hereto and incorporated herein.

Upon reviewing the procedural history of the Commission's investigation into the financial condition of EKPC, discussion turned to the current status of EKPC's current financial condition. EKPC indicated that it would likely not satisfy the financial ratios set forth in its Mortgage Agreement with the Rural Utility Service ("RUS"), but that it expected to meet the financial ratios set forth in its Unsecured Credit Facility – provided that RUS approved EKPC's proposed depreciation study.

General discussion was also held regarding the impact of Warren Rural Electric Cooperative's ("Warren RECC") recent decision to not purchase power from EKPC as originally contracted. EKPC advised that it was negotiating with Warren RECC regarding recovery of certain costs incurred as a result of the cancellation of the Membership Agreement existing between them. EKPC also broadly outlined the impact of Warren RECC's decision upon ongoing and planned construction projects.

There was also general discussion regarding the application for an adjustment of general rates that EKPC has given notice of its intent to file and the impact such a proceeding will have upon EKPC's financial condition. EKPC indicated that it would file its application as soon as possible (most likely in February of 2007) and that it would ask for an effective date for any new rates of April 1, 2007, said rates being subject to refund.

Finally, general discussion was had regarding EKPC's communications with RUS and its unsecured creditors regarding its financial condition. EKPC acknowledged that the record did not reflect the majority of such contacts – which are principally verbal – and agreed to supplement the record with additional documentation of such contacts.

There being no further items for discussion, the informal conference thereafter adjourned at approximately 11:45 a.m.
