ORDER

Southern Madison Water District, a water district organized pursuant to KRS Chapter 74, owns and operates water distribution facilities that provide water service to approximately 4,053 customers in Madison County, Kentucky. It is a utility subject to Commission jurisdiction.¹

The Commission is authorized to investigate and examine the condition of any utility subject to its jurisdiction.²

The Commission is authorized to investigate any practice or act affecting or relating to the service of a utility and, upon finding that such action or practice is unjust, unreasonable, unsafe, improper, inadequate or insufficient, to determine the just, reasonable, safe, proper, adequate or sufficient practice or method to be observed.³

The Commission is authorized to remove a commissioner of a water district from his office for good cause, including incompetency, neglect of duty, gross immorality, or

nonfeasance, misfeasance, or malfeasance in office, including, without limiting the generality of the foregoing, failure to comply with rules, regulations, and orders of the Commissioner.⁴

The Attorney General has previously opined that "commissioners of a water district organized pursuant to KRS Ch[apter] 74 are prohibited from entering into contracts with the district as a conflict of interest would exist which would be against public policy."⁵

Commission Staff has reported the following to the Commission:⁶

- 1. Jerry Combs currently serves as a member and treasurer of Southern Madison Water District's Board of Commissioners.⁷
- 2. Mr. Combs is currently paid an annual salary of \$4,800 for his services as commissioner.⁸
- 3. On September 5, 2006, during a routine Commission Staff inspection of Southern Madison Water District's records and facilities, Southern Madison Water District's general manager advised Commission Staff that the water district has contracted with Mr. Combs to serve as an inspector for a water improvement construction project for an amount not to exceed \$3,500. This compensation appears to be in addition to Mr. Combs' annual salary of \$4,800.

Based upon the foregoing and being otherwise sufficiently advised, the Commission finds that an investigation of the transaction between Mr. Combs and Southern Madison Water District should be initiated to determine if any violations of KRS Chapter 74 have occurred, if the transaction is consistent with the duties that Kentucky law imposes upon water district commissioners, and if the transaction has adversely affected the quality of service that Southern Madison Water District provides.

IT IS THEREFORE ORDERED that:

- 1. An investigation is initiated into Southern Madison Water District's contract with Mr. Combs for inspection services.
- 2. Southern Madison Water District shall, no later than December 7, 2006, file with the Commission the original and 6 copies of the information listed in Appendix B. Each copy of the requested information shall be placed in a bound volume with each item tabbed. When a number of sheets are required for an item, each sheet should be appropriately indexed, for example, Item 1(a), Sheet 2 of 6. Southern Madison Water District's response shall conform to the requirements set forth in Paragraph 3 of this Order.
- 3. a. All interrogatories and requests for production of documents shall be appropriately indexed. All responses shall include the name of the witness who will be responsible for responding to the questions related to the information provided, with copies to all parties of record and 6 copies to the Commission.
- b. Each response shall be under oath or accompanied by a signed certification of the preparer or person supervising the preparation of the response on

behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

- c. A party shall make timely amendment to any prior response if it obtains information upon the basis of which it knows that the response was incorrect when made, or though correct when made is now incorrect in any material respect
- d. For any request to which a party refuses to furnish the requested information, that party shall provide a written explanation of the specific grounds for its failure to furnish.

AFFIDAVIT

Jim Adcock, being duly sworn, states:

- 1. I am currently an employee of the Public Service Commission of Kentucky. I have been employed with the Public Service Commission since July 16, 2002.
- 2. I am employed as a water utility inspector in the Commission's Division of Engineering. As one of my duties as a water utility inspector, I periodically inspect the records and facilities of water utilities that are subject to the Commission's jurisdiction to ensure the water utilities' compliance with the provisions of KRS Chapter 278, Commission regulations, and other applicable statutes and regulations.
- 3. On October 3, 2006, I inspected the records and facilities of Southern Madison Water District. My inspection was a follow-up inspection to an inspection that I conducted earlier in 2006. Mr. Tommy Bussell, Southern Madison Water District's manger, accompanied me on this inspection. During the course of my inspection, Mr. Bussell advised me that Southern Madison Water District had contracted with Mr. Jerry Combs to serve as an inspector on the Silver Creek-Bobtown Water System Improvement Project (Contract 1). Southern Madison Water District was to pay Mr. Combs on an hourly basis but his total compensation for his inspection services was not to exceed \$3,500. Mr. Bussell acknowledged that Mr. Combs currently serves as treasurer of Southern Madison Water District's Board of Commissioners. He further stated that Southern Madison Water District's Board of Commissioners had approved the contract and that its legal counsel had reviewed the arrangement and found it proper. At my request, Mr. Bussell subsequently provided me with a copy of the contract (Exhibit A) and legal counsel's opinion (Exhibit B).
