O R D E R

This matter arises upon the motion of the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention ("Attorney General"), filed January 10, 2007, pursuant to KRS 367.150(8), for full intervention in the above proceeding. The Attorney General acknowledges in his motion that a procedural schedule was entered in this case on November 21, 2006 and that he will abide by that schedule.

Finding that such intervention is authorized by statute, and being otherwise sufficiently advised, the Commission HEREBY ORDERS that the Attorney General's motion to intervene is granted and that he shall abide by the existing procedural schedule.
