ORDER

On October 21, 2006, pursuant to 807 KAR 5:058, East Kentucky Power Cooperative, Inc. ("EKPC") filed its 2006 Integrated Resource Plan ("IRP"). In order to allow for an appropriate review of the IRP, the Commission finds that a procedural schedule should be established. The procedural schedule established herein may be modified or supplemented at a later date.

EKPC is required by 807 KAR 5:058, Section 10, to publish, in a form prescribed by the Commission, notice of its filing in a newspaper of general circulation in its service area. The Commission finds that the following format should be used when publishing notice of the IRP filing:

On October 21, 2006, East Kentucky Power Cooperative, Inc. filed its 2006 Integrated Resource Plan with the Kentucky Public Service Commission. This filing includes the most recent load forecasts of East Kentucky Power Cooperative, Inc. and a description of the existing and planned conservation programs, load management programs and power supplies it intends to use to meet forecasted requirements in a reliable manner at the lowest possible cost. Any interested person may review the plan, submit written questions to the utility, and file written comments on the plan.

Any person interested in participating in the review of this Integrated Resource Plan should, within 10 days of the publication of this notice, submit a motion to intervene to: Elizabeth O'Donnell, Executive Director, Public Service Commission, P. O. Box 615, Frankfort, Kentucky 40602.

The publication of this notice is in addition to EKPC's responsibility under 807 KAR 5:058, Section 2(2), to provide notice, upon filing its IRP, to intervenors in its most recent IRP proceeding, that its plan has been filed and is available from the utility upon request.

IT IS THEREFORE ORDERED that:

- 1. The procedural schedule in Appendix A to this Order shall be followed in this proceeding.
- 2. EKPC shall publish the notice set forth herein as required by 807 KAR 5:058, Section 10.
