## MOTION TO POSTPONE FILING DATE FOR INTERVENOR TESTIMONY

Comes now the movant, East Kentucky Power Cooperative, Inc. ("EKPC") and, as grounds for this Motion to Postpone the Filing Date for Intervenor Testimony (the "Motion"), states to the Public Service Commission (the "Commission") as follows:

- 1. EKPC and the Intervenors in this case, the Attorney General, Kentucky Industrial Utility Customers, Inc., and the Cumberland Chapter of the Sierra Club (collectively referred to as the "Parties"), have been involved in settlement discussions, and have reached tentative agreement on major elements of a settlement proposal for this case. The Parties are continuing to discuss certain issues in regard to this proposed settlement, and any final agreement must be submitted to each Party's internal approval processes.
- 2. While a proposed Settlement Agreement cannot be submitted to the Commission at this time, the Parties believe that an agreement may be reached in the near future and request that the Procedural Schedule date for the filing of Intervenor testimony be postponed from June 27, 2007 to July 5, 2007. If this postponement is granted, but no

settlement is reached, EKPC agrees that it will not request any further extensions of the remainder of the Procedural Schedule as a result of this change.

3. All of the Intervenors in this case have authorized EKPC to advise the Commission of their agreement with this Motion.

WHEREFORE, EKPC respectfully requests the Public Service Commission to amend the Procedural Schedule in this case to postpone the date for the filing of Intervenor Testimony until July 5, 2007.
