<u>O R D E R</u>

On June 25, 2007, East Kentucky Power Cooperative, Inc. ("EKPC") filed a motion seeking to postpone the filing date for Intervenor testimony. Pursuant to the procedural schedule issued on April 18, 2007, the filing of Intervenor testimony was due on June 27, 2007. EKPC requests that the filing of Intervenor testimony be postponed until July 5, 2007. In support of its motion, EKPC states that the Intervenors and EKPC have been involved in settlement discussions and have reached tentative agreement on major elements of a settlement proposal for this case. EKPC and the Intervenors are continuing their discussions and believe that an agreement may be reached in the near future. Thus EKPC, with the agreement of the Intervenors, is requesting the postponement and further states EKPC would not request further extensions of the remainder of the procedural schedule if no settlement is reached.

The Commission finds EKPC has provided good cause to support its request for a postponement. However, granting EKPC's request will require that other dates in the April 18, 2007 procedural schedule be changed. The Commission hereby amends the procedural schedule of April 18, 2007 and adopts the schedule included in Appendix A, attached hereto and incorporated herein.
