Since Grayson Pailed to bring an action within the proper statue of limitation that hars all action for goods delivered under the Statue of limitations KRS. 355. 2-105 (2) the sale of electricity was a sale of goods governed by the provisions of KRS. Chapter 355; and (3) any action involving the sale of electricity was governed by the 4-year statue of limitations contained in KRS. 355. 2-705. According to the Kir Court of appeals ralings
