MOTION FOR EXTENSION OF TIME

Brandenburg Telephone Company ("Brandenburg Telephone"), by counsel, respectfully moves the Public Service Commission of the Commonwealth of Kentucky (the "Commission") for a one week extension of time for the parties to file Rebuttal Testimony in this case.
