
Dear Mr. Ridings:

This is a follow up to our telephone conversation of today. As I explained, the letter that you sent to the Public Service Commission dated October 18, 2006 is your application for a transfer of ownership of W & W Service Company. As I pointed out, you will need to have that letter properly notarized for the Commission to process it as your application. I have enclosed a copy of the Kentucky statute for notary acknowledgments. Please use the appropriate form on your letter.

Also please prepare a financial statement and attach it to your application. It would also be helpful if you would include a copy of your operator's license. As I also stated, the Commission is going to require a Third Party Beneficiary document. I have enclosed a copy of such document submitted by a utility in a previous case. Please discuss with your bank and see if you can obtain a letter of credit. Once we have a notarized application and the financial statement, we can process your application to transfer the W & W Service Company to you.
