MOTION OF EAST KENTUCKY POWER COOPERATIVE, INC., TO SCHEDULE AN INFORMAL CONFERENCE

East Kentucky Power Cooperative, Inc. ("EKPC"), hereby moves the Commission to schedule an informal conference in this case. The grounds for EKPC's motion are as follows:

- 1. The Public Service Commission (the "Commission") initiated this investigation to determine EKPC's need for generating facilities approved in PSC Cases No. 2004-00423 and No. 2005-00053, in light of the decision by Warren Rural Electric Cooperative Corporation to terminate its future power supply arrangement with EKPC. The Commission has recently extended the procedural schedule in this investigation to more fully evaluate the need for the facilities approved in PSC Case No. 2005-00053, has issued new data requests, and has scheduled a hearing for March 6, 2007. EKPC has recently evaluated certain scheduling complications relating to the Smith Station CFB Unit 1 project, and complications in contractual negotiations relating to the Smith Station CT 8-9 project, and has determined that significant modifications to the plans for both projects are needed.
- 2. Before responding to the Commission's most recent data requests in this case, EKPC desires to discuss these project changes with the Commission Staff and the

Parties of Record in an informal conference, and has determined that Thursday, February 22, at 3:00 p.m. EST is an acceptable time for all participants.

. WHEREFORE, EKPC formally moves the Commission to schedule an informal conference in this case at the above-stated date and time, or at some other time acceptable to the Commission Staff and all Parties.
