
MOTION TO CONTINUE
INFORMAL CONFERENCE

Windstream Kentucky East, LLC (“Windstream”), by counsel, hereby moves the Public Service Commission of the Commonwealth of Kentucky (“Commission”) to continue the informal conference currently scheduled for July 8, 2008 to August 7, 2008, or such other time as will be convenient for the Commission and the Complainants.

In support of this motion, Windstream states that the parties have conducted regular negotiations focused on the resolution of the issues presented in this matter, and that Windstream has been able to resolve many of the routing issues with certain of the Complainants on a going-forward basis. Windstream believes the requested continuance of the informal conference will allow for continued negotiations of remaining issues and the likelihood of further progress

toward the ultimate resolution of this matter. Counsel for Windstream has conferred with counsel for the Complainants and counsel stated that Complainants do not object to this motion. Accordingly, Windstream moves the Commission to continue the July 8, 2008 informal conference to August 7, 2008, or such other time as will be convenient for the Commission and the Complainants.


