ATTORNEY GENERAL'S COMMENTS REGARDING MOTION OF INTERSTATE GAS SUPPLY, INC. TO INTERVENE

Comes now the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention, and tenders the following comments regarding the motion of Interstate Gas Supply, Inc. ["IGS"[to intervene in the above-styled action.

IGS is the largest competitive supplier in Columbia's choice program, supplying gas to over 26,000 of Columbia's customers. Columbia's proposed rate adjustment in the instant matter will affect the rate applicable to its customers using the Choice program. IGS alleges that the effect of this proposed rate adjustment will be unequally allocated between Choice customers and non-choice customers. In particular, IGS alleges that under the proposed adjustment, its customers would be required to make a double payment, and that if approved, the adjustment would detrimentally affect IGS' ability to compete in the marketplace.

The Attorney General believes that a full and just resolution of the issues in the instant matter cannot be made without granting IGS full intervention. As

such, the Attorney General fully supports IGS' motion, and urges the Commission to approve IGS' motion.
