



Bring garden freshness indoors

Nothing can liven up a best treated as annuals, if keep the soil moist, but not menu like the taste of herbs tainers beneath the pots.

Don't rush to bring the newly transplanted herbs inside. Instead, allow the plants to adjust to their new environment by moving them out of direct sunlight for about a week. This will accustom the plants to the lower light conditions they will experience indoors. Then bring the pots inside a few hours at a time for another five to seven days, after which it is safe to move them inside permanently. Watch for hitchhiking insects. Hit the plants with a strong stream of water to knock pests off or use an insecticidal soap before introducing the potted herbs to your houseplants. Unless you have a very bright window, these perennial herbs may not flourish for more than a few weeks to a month, but at least you will be extending their season of use. Annual herbs, such as basil and cilantro, are best planted from seed. Chives, though perennial, might be
