ORDER

On April 20, 2007, Delta Natural Gas Company, Inc. ("Delta") submitted an application to the Commission requesting authority to adjust its rates utilizing a historic test period. The Commission issued an Order on May 15, 2007 establishing a procedural schedule for the processing of this case.

On its own motion, the Commission finds that, in light of the August 1, 2007 Opinion and Order entered by the Franklin Circuit Court in the matter of *Commonwealth of Kentucky, ex rel. Gregory D. Public Service Commission and Union Light, Heat and Power Company,* Civil Action No. 06-CI-269, the procedural schedule established in our May 15, 2007 Order should be amended to allow additional information to be requested from Delta concerning its gas commodity costs. 1. The procedural schedule set forth in Appendix A, which is appended hereto and incorporated herein, shall be followed and supersedes the previous schedule established in the Commission's May 15, 2007 Order.

2. Nothing contained herein shall prevent the Commission from entering further Orders in this matter.
