WHEREAS, the undersigned, Kentucky Power Company, is willing to accept said

Ordinance granting said franchise in accordance with the terms and conditions therein

set forth.

NOW, THEREFORE, the said Kentucky Power Company hereby assents to and

accepts the terms and provisions of said Ordinance and agrees to be bound and abide

by said terms and provisions as in said Ordinance set forth.
