#### NOTIFICATION OF PROGRESS AND STATUS OF LINE REPLACEMENT AS ORDERED BY THE COMMISSION

Comes now Mike Little Gas and reports the following progress and status of line repair and replacement and states as follows:

- 1. That by order of the Commission, Mike Little Gas was to complete steel pipe replacement before November 1, 2007.
- The project was on schedule to be completed on or before November 1, 2007, as ordered by the Commission, when a material delay was caused by directives from the Department of Transportation, to cease construction.
- 3. Mike Little Gas then filed a request for an extension of time to complete the project with the Commission.
- 4. Numerous attempts were made to obtain permission from the Department of Transportation to complete the project and request was made to the DOT for a valid basis for the directive to cease construction, which to date has not been provided.
- 5. Notwithstanding, Mike Little Gas has continued to do some work toward completion of the project.
- 6. It is anticipated that contingent upon approval from the Commission, Mike Little Gas will be selling to Frontier Gas on or before September 1, 2008, additionally, Frontier Gas will likely take over the management of Mike Little Gas prior to the transfer in September.
- 7. Frontier Gas has been apprised of the situation with pipe replacement and understand the urgency of completing the project.
- 8. Representatives of Frontier Gas have been to the construction site and are currently making plans to begin replacing the pipe.
