SECOND NOTIFICATION OF PROGRESS AND STATUS OF LINE REPLACEMENT AS ORDERED BY THE COMMISSION

Comes now Mike Little Gas and reports the following progress and status of line repair and replacement and states as follows:

- 1. That by order of the Commission, Mike Little Gas was to complete steel pipe replacement before November 1, 2007.
- 2. Despite numerous delays, substantial progress has been made toward pipeline repair and replacement of steel pipe, with more than 80% of the project completed.
- 3. That the project was on schedule to be completed on or before November 1, 2007, as ordered by the Commission.
- 4. On October 9, 2007, a representative from the Department of Transportation, Gene Layne, (his job title is currently unknown) notified an employee of Mike Little Gas that the line repair and replacement was not in compliance with DOT regulations and that construction must immediately cease.
- 5. Mike Little is currently making every attempt to learn the basis for noncompliance in order to become compliant and resume work.
