REPORT OF STATUS

COMES NOW Miki Thompson, President and counsel for Mike Little Gas, and files this update of progress of the steel pipe replacement as ordered by the Commission. Mike Little at the present time has suspended the steel pipe replacement at the direction of the Department of Transportation, stating that the line is on the wrong side of the highway. Mike Little has done the majority of the work at the site to complete the project, but cannot move forward due to DOT directive to stop work.

At the present time, Mike Little has three options to complete the project. First, there has been discussions with Danl L. Hall, Executive Director and Chief Engineer, of District 12 of the Department of Highways, 109 Loraine Street, Pikeville, KY 41501, who has indicated that he will personally take another look at the current project and make a determination whether the work may be completed as planned. In the event the plan is not approved, then Mike Little will file suit in Floyd County requesting the use of its easement over the right of way and to replace the existing steel pipe as planned. If that request is rejected, Mike Little will make attempts to run the plastic pipe behind private houses and beside the railroad right of way. This will take considerable more time and costs, and will require crossing private property. Mike Little is currently making a determination the owners of the private property and the additional supplies and equipment necessary to take the alternative route. If for some reason that plan fails, the final option is to apply for a permit for the opposite side of the highway.
