

Pursuant to the Commission Staff's May 5, 2008 Notice of Informal Conference, an informal conference was held on May 6, 2008. Attached to this memorandum as Attachment 1 is a list of the participants. The purpose of the conference was to discuss the terms of a settlement agreement reached between Jackson Purchase Energy Corporation ("Jackson Purchase") and the Office of the Attorney General ("AG") and other procedural issues.

Jackson Purchase briefly reviewed the terms of the settlement agreement and noted that the only changes contained in the tariffs attached to the settlement agreement are to the rates to be charged for service.

Commission Staff asked a few clarifying questions related to the settlement agreement and noted some of these issues may be raised at the public hearing on May 13, 2008.
