RESIDENTIAL AND COMMERCIAL SERVICE SHALL CONSIST OF A ³/₄ INCH OFF 3 INCH CONNECTION TO THE DISTRICTS MAIN, A ³/₄ INCH SERVICE LINE AND A METER SETTER ENCLOSED ON A CONCRETE OR CLAY BOX WITH A METAL COVER. SERVICE OF A LARGER SOZE MAY BE INSTALLED IF THE COUSTOMERS EXPECTED USE WILL JUSTIFY SUCH INSTALLATION.
- 2. METERS WILL BE INSTALLED IN THE SERVICE AT THE CUSTOMERS REQUEST PROVIDED THE REQUIRED DEPOSIT AND SERVICE INSTALLATION COSTS (IF ANY) HAVE BEEN MADE OR TERMS OF PAYMENT HAVE BEEN AGREED TO.
- 3. SERVICE AND INSTALLATIONS TO A LOCATION WHERE NE SERVICE LINE HAS PREVIOUSLY BEEN INSTALLED WILL BE PAID FOR AT ACTUAL COST BY THE CUSTOMER. THE COSTS WILL CONSIST OF LABOR AND MATERIALS DETERMINED BY THE WATER SUPERINTENDENT. 
