LEXINGTON-FAYETTE URBAN COUNTY GOVERNMENT'S MOTION TO ESTABLISH DEADLINE

Comes now the Lexington-Fayette Urban County Government (the "LFUCG"), by counsel, and moves the Public Service Commission to establish a deadline with respect to further intervention related to the consideration of competing proposals and the filing of information related to such proposals for the reasons provided below.

The water supply deficit issue still remains unresolved years after it was identified, and under the current procedural schedule in this matter a decision on Kentucky-American Water Company's application is not likely before the end of this year. Louisville Water Company has now intervened in an apparent attempt to have the Public Service Commission deny the application, and instead endorse its proposal.

In order to ultimately resolve the water supply deficit issue on a timely basis, an additional deadline should be considered in this case in order to establish a date certain for the filing of any and all information relevant to any competing proposal.

The LFUCG defers to the Commission on establishing the appropriate date or dates for any such deadlines.
