This letter relates to Case No. 2007-00154, Delta's Energy Assistance Plan ("EAP) as approved by the Commission in Case No. 2005-00464.

As requested by Commission Staff, based upon the discussions at the informal conference at the Commission on April 24, 2007, Delta suggests the following to be filed as an evaluation of the EAP:

A report by the Community Action Council, to include:

Details of their billings to Delta

Description of their accounting for program costs
Breakdown of EAP enrollees by county or district office in relation to
Delta's customer base in each county or district office
EAP administrative costs expected for 2007 and the next three years
Certify enrollees as EAP and Liheap eligible

Delta has been and is operating its EAP as approved by the Commission in its Order on February 1, 2006. We appreciate the Commission extending our EAP past April 30, 2007 and until such time as the Commission considers it further and rules in Case No. 2007-00054. We believe that the EAP has been a benefit to our customers. We are willing to continue it as is at the \$.20 monthly customer charge amount and to continue our company contribution of \$30,000.00, but we anticipate recovery of said amount in rates in the future. We desire no changes to the EAP.

We reviewed the LG&E order (Case No. 2004-00304) and the KU order (Case No. 2004-00303) provided to us at the informal conference and we note nothing therein that changes our analysis or that requires further changes to our EAP.

In accordance with the Commission's Order dated April 30, 2007 in this proceeding, Delta is also herewith filing the original and four copies of its revised tariff sheet, Sheet No. 35, showing the date of issue and that it was issued by authority of said Order. Please return a stamped copy of the tariff to Delta.

ENERGY ASSISTANCE PROGRAM RIDER APPLICABLE TO RESIDENTIAL RATE SCHEDULE

N ENERGY ASSISTANCE PROGRAM

An Energy Assistance Program ("EAP") surcharge of \$0.20 per month will be applied to all residential bills rendered under the Residential Rate Schedule. It shall be added to Delta's existing customer charge as set forth on Sheet No. 2 of this tariff. Proceeds from the EAP surcharge will help fund a bill credit to enrolled low-income customers. It is available to eligible residential customers in the Company's service territory subject to enrollment through local community action agencies and subject to available funding.
