Exchange Service Effective November 12, 2007

Pursuant to the Commission Staff's notice of October 19, 2007, an informal conference was held in this matter on Friday, November 2, 2007. A copy of the conference attendance list is attached. In attendance were Commission Staff, representatives for North Central Telephone Cooperative Corporation ("North Central"), counsel for North Central, counsel for the Office of the Attorney General, and counsel for Verizon.

The purpose of the conference was to discuss North Central's Motion for Waiver from Certain Filing Requirements ("Motion for Waiver"). On October 11, 2007, North Central filed a rate application using a future-forecast test period. North Central also filed the Motion for Waiver on October 11, 2007.

During the conference, Commission Staff reviewed each of the nine waiver requests submitted by North Central. North Central and its counsel were given time to comment on the basis for each request.

The parties also discussed Commission Case No. 2007-00432, a companion case filed by North Central, wherein the cooperative is seeking a certificate for cable construction. Commission Staff had previously issued a data request in that matter. North Central's responses were due on November 2, 2007. North Central stated that it had filed a motion for additional time to file the responses. All parties agreed that the responses to the data request would provide significant and useful financial forecast information that could be relevant to North Central's rate case.

Counsel for Verizon stated that the company had moved for full intervention in the rate case. Counsel for North Central stated that an objection to that motion would be submitted to the Commission. The Attorney General's office stated that, within the coming days, the office would make a final determination on whether it would intervene in the rate case. The conference was then adjourned.
