# <u>ORDER</u>

2. Ordering Paragraph 5 of the February 1, 2008 Order is amended to read

as follows:

Big Rivers and Kenergy, after providing written notice to the Commission, are authorized to establish deferred accounts in which to record unrecovered costs associated with the pilot RTP program. 3. All provisions of the February 1, 2008 Order that are not in conflict with the terms of this Order shall remain in effect.
