ORDER

On April 20, 2007, Big Rivers Electric Corporation ("Big Rivers") and Kenergy Corp. ("Kenergy") submitted a joint application to the Commission for amendments to existing tariffs to implement a voluntary real-time pricing pilot program for large commercial and industrial customers. On October 2, 2007, Big Rivers and Kenergy submitted an amendment that included new tariffs with proposed effective dates of November 2, 2007.

Based on a review of the new tariff proposals, the Commission finds that an investigation will be necessary to determine the reasonableness of the proposed tariffs and that the investigation cannot be completed by November 2, 2007. Therefore, pursuant to KRS 278.190(2), the Commission will suspend the effective date of the proposed tariffs for 5 months.

IT IS THEREFORE ORDERED that, pursuant to KRS 278.190(2), Big Rivers' and Kenergy's proposed tariffs are suspended up to and including April 1, 2008.
