Sprint PCS shall make timely amendment to any prior responses if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any requests to which Sprint PCS fails or refuses to furnish all or part of the requested information, Sprint PCS shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations.

The requested information is as follows:

1. Provide a list of other arbitration matters involving Sprint PCS that have been submitted to other state commissions wherein the issue presented concerned the commencement date for a new interconnection agreement in consideration of Federal Communications Commission Order 06-189, Appendix F, Merger Commitment No. 4:

b. Provide the case number for the arbitration.

2. For each arbitration matter listed in your response to Item No. 1, state if an Order has been issued by the presiding Commission wherein the Commission issued a ruling on the commencement date for the interconnection agreement.
