TO FILE THEIR RESPECTIVE BRIEFS

Comes now the Complainant Carroll County Water District No. 1 (hereinafter referred to as "CCWD"), and moves this Commission for an extension of time for the parties to file their respective Briefs, currently due to be filed by November 30, 2007, and granting the parties an additional twenty (20) days up to and including December 20, 2007, to file their respective Briefs.

In support of said motion, CCWD states as follows:

1. Court Reporter Connie Sewell advised the parties following the November 1, 2007, hearing that due to the length of the proceedings which were all day and constituted ten (10) tapes, that the transcript would likely not be filed until November 19, 2007, which will give the parties only ten (10) days within which to file their Briefs;




