COMMISSION STAFF'S FIRST DATA REQUEST
TO CARROLL COUNTY WATER DISTRICT NO. 1

Carroll County Water District No. 1 ("Carroll District"), pursuant to 807 KAR 5:001, is requested to file with the Commission the original and six copies of the following information, with a copy to all parties of record. The information requested herein is due on or before October 1, 2007. Responses to requests for information shall be appropriately bound, tabbed and indexed. Each response shall include the name of the witness responsible for responding to the questions related to the information provided.

Each response shall be answered under oath or, for representatives of a public or private corporation or a partnership or association or a governmental agency, shall be accompanied by a signed certification of the preparer or person supervising the

preparation of the response on behalf of the entity that the response is true and accurate to the best of that person's knowledge, information, and belief formed after a reasonable inquiry.

Carroll District shall make timely amendment to any prior responses if it obtains information which indicates that the response was incorrect when made or, though correct when made, is now incorrect in any material respect. For any requests to which Carroll District fails or refuses to furnish all or part of the requested information, Carroll District shall provide a written explanation of the specific grounds for its failure to completely and precisely respond.

Careful attention should be given to copied material to ensure that it is legible. When the requested information has been previously provided in this proceeding in the requested format, reference may be made to the specific location of that information in responding to this request. When applicable, the requested information shall be separately provided for total company operations and jurisdictional operations.

1. Provide a copy of all ordinances and resolutions of Carroll County Fiscal Court that address the territory of Carroll District.
2. Provide a copy of all ordinances and resolutions of Gallatin County Fiscal Court that address the territory of Carroll District.
3. Provide a copy of all orders of the Carroll County Judge/Executive that address the territory of Carroll District.
4. Provide a copy of all orders of the Gallatin County Judge/Executive that address the territory of Carroll District.

5. a. State whether, prior to October 8, 1998, Gallatin County Water District's ("Gallatin District") territory included any of the geographical area that the County Judge/Executives of Carroll, Gallatin, and Owen counties added to Carroll District's territory by their Order of October 8, 1998.

b. If the response to Item 5(a) is yes, provide a copy of the Order of the Gallatin County Judge/Executive striking off the territory from Gallatin District's territory.

6. Refer to the Carroll District's complaint at ¶ 4.

a. Provide a detailed description of the "new commercial development." This description should include an estimate of the new commercial development's water supply requirements.

b. Describe the current status of the construction of the new commercial development.

c. State the name and mailing address of the owner of the new commercial development.

d. Provide an exact description of the location of the new commercial development. The description set forth in the complaint does not constitute an exact description.

7. Provide a map of the area within a 4-mile radius of the new commercial development. The scale of this map should not be less than 1 inch = 1000 feet. The map should indicate, at a minimum, the new commercial development, all existing roads, all existing Carroll District and Gallatin District water distribution facilities, and the territorial boundaries of each water district and all political subdivisions in the area.

8. a. List and describe all facilities that Carroll District must construct or install to provide water service to the new commercial development.

b. State the cost of each facility listed in response to Item 8(a).

c. State the length of time necessary to plan and construct each facility listed in response to Item 8(a).

9. Provide all correspondence between Carroll District and Gallatin District regarding water service to the disputed area.

10. List and describe all contacts between representatives of Carroll District and the new commercial development regarding water service to that development.


11. State whether Carroll District takes the position that a water district has the exclusive right to provide water service within its territory. List the legal authorities upon which Carroll District bases its position.

12. State whether Carroll District takes the position that the same geographical area cannot be in the territorial boundaries of two water districts. List the legal authorities upon which Carroll District bases its position.

13. Refer to Gallatin District's answer at ¶ 5. State whether Carroll District consented or acquiesced in the construction of the facilities to which Gallatin District refers. Explain.

14. List all bonds, notes, and other debt instruments of Carroll District that Rural Development presently holds. For each listed debt instrument, state the date of issuance, the original amount of the instrument, the current outstanding balance, and the expected date that the debt instrument will be retired.

15. Provide the minutes of each meeting of the Carroll District Board of Commissioners since January 1, 1996 in which water service to the disputed area was discussed, including any discussions regarding Carroll District's annexation of the disputed area.
