Dear Ms. O'Donnell:

The Wood Creek Water District Wastewater Division respectfully requests that the Commission allow us to make an adjustment in our rates in accordance with 807 KAR 5:067 Purchased Water Adjustment Clause.

Our District currently has approximately 800 wastewater customers. We pump the wastewater to the City of London for treatment. The previous rate paid to the City is \$2.48 per 1,000 gallons. The rate has been increased to \$2.63 per 1,000 gallons.


During the 12 month period ending April 2007, we paid the City of London \$73,639.63 for treatment of 29,693,400 gallons. Our wastewater billing during that period was \$206,010.95 based on water usage of 38,920,900 gallons. The difference between the old cost and new cost to treat would be \$4,454.01 and the adjustment factor would be .1144 per 1,000 gallons. We propose to add \$0.1144 to each block of our current wastewater rates.


The increased water cost is the cost difference between purchases at base (current rate) and purchases at new rate.

6. Purchased water adjustment factor .1144 per 1,000.

The purchased water adjustment factor is obtained by dividing the increased cost of water by the total gallons sold.  $\$4,454.01 / 38,920,900 \times 1,000$

Note: The purchased water adjustment factor is added to each thousand gallons sold. If the minimum usage is 2,000 gallons then the purchased water adjustment factor would be added to the minimum bill twice. Revised tariff sheets must be attached showing the rate to be charged by the utility and the effective date of the increased rates.

Dear Sirs:

This is to inform you of our intent to file a rate tariff with the Kentucky Public Service Commission adjusting your wholesale sewer rate. The adjustment will be in accordance with Section 2 of the Purchase Contract dated October 20, 2004 and Section 6 of City of London Ordinance # 2004-17. The adjustment of rates based on the CPI will be as follows:

<u>Current Rate</u>	<u>% Increase Based on CPI</u>	<u>Revised Rate</u>
\$2.48/1000 gal.	3.5 (2004-2005)	\$2.57/1000 gal.
\$2.57/1000 gal	2.4 (2005-2006)	\$2.63/1000 gal.

In keeping with the contents of City of London Ordinance # 2004-17, the first rate listed should have been implemented in 2006, however, this was not done due to an oversight. The current billing rate is still \$2.48/1,000 gallons. Upon approval of PSC, the effective rate will be \$2.63/1,000 gallons.


