

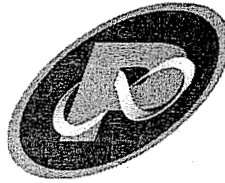

The revised rate schedule, effective on and after July 9, 2007, is as follows:

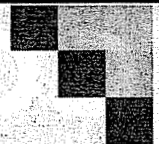
