
On July 31, 2007, the Commission ordered North Marshall Water District ("North Marshall") to show cause as to why it should not be subject to penalties prescribed in KRS 278.990(1) for allegedly failing to comply with KRS 278.160. North Marshall responded on August 16, 2007 and stated, *inter alia*, "an informal conference is not necessary, given the multitude of facts which are favorable to" North Marshall.¹

IT IS THEREFORE ORDERED that North Marshall shall have 15 days from the date of this Order to file a written request for a formal hearing in this matter. If no request for a formal hearing in this matter is received within that time, this case shall stand submitted for a decision on the existing record.
