O R D E R

On July 12, 2007, MCI Access Transmission Services, LLC and South Central Rural Telephone Cooperative Corporation, Inc. submitted to the Commission, their request for expedited approval of an agreement for facilities-based network interconnection for the exchange of information service provider traffic. The agreement was negotiated pursuant to the Telecommunications Act of 1996, 47 U.S.C. §§ 251 and 252.

The Commission has reviewed the agreement and finds that no portion of the agreement discriminates against a telecommunications carrier not a party to the agreement. The Commission also finds that the implementation of this agreement is consistent with the public interest, convenience and necessity.

The Commission, having been otherwise sufficiently advised, HEREBY ORDERS that the request of MCI Access Transmission Services, LLC and South Central Rural Telephone Cooperative Corporation, Inc. for expedited approval of their proposed interconnection agreement is granted effective the date of this Order.
