Re: Formal Application for Tariff Revisions & to Increase non-recurring charges

This is an application to revise language and certain non-recurring charges for the Green River Valley Water District. Attached is the non-recurring charge cost justifications and the proposed new tariff.

Green River Valley Water District is not requesting a water rate increase at this time. However, increased costs attributable to certain non-recurring charges can no longer be absorbed by the District. The customers affected by these increases will be the customers that cause the District to incur these additional expenses.

The District has previously filed income statements and balance sheets with the Public Service Commission. These income statements and balance sheets are currently on file with the Commission.

The District will publish the enclosed public notice of these requested rate revisions in the local newspaper for three consecutive weeks. The first notice has already been published and the newspaper ad is enclosed. 




