**BRANDENBURG TELEPHONE COMPANY'S RESPONSE TO
THE COMMISSION'S NOVEMBER 21, 2007 ORDER**

Brandenburg Telephone Company ("Brandenburg Telephone"), by counsel, hereby responds to the November 21, 2007 order of the Public Service Commission of the Commonwealth of Kentucky (the "Commission").

REQUEST NO. 1

Provide the billing history for the disputed account (270-496-4992) and the undisputed account (270-496-4836) beginning with the January 2006 billing period through the current period.

Responsible Witness: Allison T. Willoughby

RESPONSE:

An outline of the billing history for the disputed account (270-496-4992), along with copies of the bills from January 2006 through May 2007, is attached as Exhibit A. As the attached outline indicates, the account had an outstanding balance of \$166.30 at the time Mr. David Stauffer requested disconnection on May 30, 2007. Additional charges that accrued on the disputed account after the May 1, 2007 bill and before the

May 30, 2007 request for disconnection were included on the June 1, 2007 and July 1, 2007 bills on the active, undisputed account (270-496-4836). The total outstanding balance on the disputed account, as indicated in the attached outline of the billing history, is \$228.37.

An outline of the billing history for the undisputed account (270-496-4836), along with copies of the bills from January 2006 through November 2007, is attached as Exhibit B. As the attached outline indicates, Mr. Thomas Dean Stauffer owed \$30.87 on this account as of the August 1, 2007 bill. He remitted a check for \$30.00 on August 29, 2007 but stopped payment on the check on September 5, 2007. The entire August bill in the amount of \$30.87 remains unpaid.

In Mr. Stauffer's response to Brandenburg Telephone's motion to require him to pay undisputed charges, Mr. Stauffer states that "[p]art of the \$30.87 is in dispute, as it includes unwarranted late fees and doesn't give credit for the overpayment in the month of July 2007." (Response, p. 1). As the attached billing outline reflects, the August 2007 bill does account for the \$.05 overpayment in July. In addition, even if Mr. Stauffer disputes the \$2.54 late fee, that leaves \$28.33 (\$28.38 [local charges] - \$.05 [(credit)]) in undisputed, unpaid charges.

REQUEST NO. 2

Provide a description of Brandenburg Telephone's policy regarding transfer of past-due balances to active accounts with references to relevant tariff provisions, if any.

Responsible Witness: Allison T. Willoughby

RESPONSE:

It is Brandenburg Telephone's policy to transfer the outstanding balance of an inactive account to an active account when the same individual is a responsible party on both accounts. The company's policy is consistent with KRS 278.030 which provides that a utility "may establish reasonable rules governing the conduct of its business and the conditions under which it shall be required to render service." Moreover, Brandenburg Telephone is statutorily obligated to collect its tariffed rates and not discriminate with regard to rates or service.

No utility shall charge, demand, collect or receive from any person a greater *or less* compensation for any service rendered than that prescribed in its file schedules, and no person shall receive any service from any utility for a compensation greater or less than that prescribed in such schedules.

KRS 278.160(2). Similarly, "[n]o utility shall, as to rates or service, give any unreasonable preference or advantage to any person" KRS 278.160(1). Brandenburg Telephone's policy ensures that the company complies with these statutory mandates.

REQUEST NO. 3

Provide any documents in possession of Brandenburg Telephone that Mr. Stauffer, his wife or their representative has signed.

RESPONSE:

REQUEST NO. 4

Provide a description of Brandenburg's policy of applying payments to arrears for inactive accounts when payment is made on an active account.

RESPONSE:

When Brandenburg Telephone transfers a balance from an inactive account to an active account, absent alternative arrangements made in cooperation with the customer, Brandenburg Telephone applies payment first to current charges, and then to the oldest balance.


