THOMAS DEAN STAUFFER'S ANSWER TO THE MOTION TO REQUIRE COMPLAINANT TO PAY OUTSTANDING "UNDISPUTED" CHARGES AND TO KEEP CUSTOMER ACCOUNT CURENT

Thomas D. Stauffer hereby files an answer to the defendant's motion, "To require Thomas Dean Stauffer ("Complainant") to pay his outstanding undisputed charges and keep his account with Brandenburg current." The Defendants Bold assumption that the "\$30.87" is undisputed only reinforces the fact that Brandenburg Telephone can't be trusted to properly account for the payments made on this account.

Part of the \$30.87 is in dispute, as it includes unwarranted late fees and doesn't give credit for the overpayment in the month of July, 2007. Again if these accounts had been left separate there would not be any of these problems. Please refer to the original complaint, Page two paragraph one.

Complainant objects to the Defendants arrogant statement in paragraph two of their motion, sentence two, "The amount that the Complainant disputes is \$228.37, and that amount relates to an account (270-496-4992; the Disputed account) for which the complainant is a responsible party." The complainant had nothing to do with that account! In fact when I went to the Phone company to talk to them about it, they refused to discuss it with me as I was not a signee on that account. The Defendants obviously don't understand the premise of this complaint, and that is that they have charged me for an account that I am in no way responsible for!

As for the current charges, the defendant in their motion so stated that we paid for the month of September, and I also paid for October, on the 5th of October. Therefore their claimed fear of non-payment is totally unfounded. My wife and I have been customers of Brandenburg Telephone since 1991 and have never had our phone shut off for non-payment!

The original complaint was filed September 11 and served September 19, 2007. The amount in question stems from August, 2007, and therefore is included in this Complaint. The complaint so states that my wife went in to pay what we owed and was told that she had to pay three months in order to prevent interruption of service! This was in violation of what we were told by the Commission! If they had not harassed my wife to the point of mental breakdown, they would have been paid!

I admit it has not been easy to deal with Brandenburg Telephone since this filing. When I went in to pay the last two payments, I was grilled as to who I was and asked for my Social Security number, and asked about the "credit payment on the balance." It makes it difficult to deal with them as they are only open during my working hours, and for obvious reasons I will never have my wife talk to them again! I can't pay on line because their system will only accept the minimum balance. If I pay by mail I would have to send it certified in order to prove that they received the payment on time. So I

end up loosing time from work just to pay the bill so I can get a receipt, and then have to put up with their harassment!

It should be obvious by the wording of their motion and their actions that they have no intention of abiding by the stay issued by the Commission, and to force payment of the disputed account by intimidation and any other means possible whether legal or illegal.

Enclosed you will find copies of my receipts for the payments for September and October, 2007.
