### THOMAS DEAN STAUFFER'S RESPONSE TO BRANDENBURG TELEPHONE'S DEFIANCE OF THE COMMISSIONS ORDER OF THE 21<sup>st</sup> OF NOVEMBER 2007.

NEW EVIDENCE: LETTER FROM BRANDENBURG TELEPHONE THROUGH THEIR ATTORNEY'S OFFICE, DATED JANUARY 10, 2008, AND SIGNED BY THE C.E.O. OF BRANDENBURG TELEPHONE, J. D. TOBIN, III.

- On Friday, January 11, 2008, we received the enclosed letter stating that our telephone service will be terminated for lack of payment of \$28.33 in local service charges billed in August 2007. This billing is still in dispute as we were not given credit for over payments made the previous months.
- Please note that even though this letter is on their attorney's letterhead there is no CC: or reference to a copy being sent to the Commission. Also both came in envelopes from Brandenburg Telephone Company and were mailed from the 40108 zip code. Both were addressed to my wife Ilissa but the letters inside were addressed to me.

- 3. On October 5, 2007, Brandenburg filed a motion requesting that the Commission require "Mr. Stauffer" to pay his "Outstanding undisputed charges and keep his customer account with Brandenburg current. They also requested the right to terminate my telephone service if I fail to pay the amount that was prior to the filing of this dispute of September 11, 2007.
- In the Commission's order of November, 21, 2007, The Commission specifically denied Brandenburg's motion and further warned them of the penalties listed under K.R.S. 278.990.
- 5. I have checked the Commission's web sight to see if there had been any other ruling on this, and found none.
- 6. I had noticed the last few bills have been late arriving and they were only photocopies and not the originals. As of Today, January, 13, 2008, I still have not received my January 1, 2008 bill!
- 7. Every-time I go in person to pay the bill, I am questioned about the previous balance and they act as if this dispute filed with the Commission doesn't exist! It seems that they have no respect for the law or of the Commission and will do what ever they want to because they have a monopoly!
- 8. My wife has serious medical needs and has had to make a 911 call for emergency in the past. If Brandenburg terminates service it would endanger her life as she does not have a cell phone or know how to use one. I also have to fax my paperwork in to the office every night from home and I cannot do it on my cell phone!

 Personally I have no problem with them terminating my phone service as long as Brandenburg Telephone and Mr. Tobin get the maximum penalties allowed under KRS 278.990.
