ORDER

On June 30, 2004, in Case No. 2003-00433,<sup>1</sup> the Commission approved rates for Louisville Gas and Electric Company ("LG&E") and provided for their further adjustment in accordance with LG&E's Gas Supply Clause ("GSC").

On September 28, 2007, LG&E filed its proposed GSC to be effective November 1, 2007.

After reviewing the record in this case and being otherwise sufficiently advised, the Commission finds that:

1. LG&E's notice includes revised rates designed to pass on to its customers its expected change in wholesale gas costs.
2. LG&E's Expected Gas Cost ("EGC") is \$.85907 per 100 cubic feet, or \$8.5907 per Mcf, which is \$.1541 per Mcf less than the previous EGC of \$8.7448 per Mcf.
3. LG&E's notice sets out no current Refund Adjustment ("RA"). LG&E's notice sets out no total RA, which is no change from the previous total RA.

4. LG&E's notice sets out a current Actual Adjustment ("AA") of (\$.1141) per Mcf. The total AA of \$.3194 per Mcf is a decrease of \$.0958 per Mcf from the previous total AA.

5. LG&E's notice sets out a (\$.1234) per Mcf current Balance Adjustment ("BA"), which is an increase of \$.3755 per Mcf from the BA.

6. LG&E's notice sets out its Performance-Based Rate Recovery Component ("PBRRC") of \$.161 cents per Mcf, which will remain in effect to collect LG&E's portion of PBR savings until January 31, 2008.

7. LG&E's Gas Supply Cost Component ("GSCC") is \$.89477 per 100 cubic feet or \$8.9477 per Mcf, which is \$.1256 per Mcf more than the prior GSCC of \$8.8221 per Mcf.

8. The rate in the Appendix to this Order is fair, just, and reasonable, and should be approved for gas supplied by LG&E on and after November 1, 2007.

IT IS THEREFORE ORDERED that:

1. The rate in the Appendix, attached hereto and incorporated herein, is approved for gas supplied on and after November 1, 2007.

2. Within 20 days of the date of this Order, LG&E shall file with the Commission its revised tariffs setting out the rate authorized herein.
