E.ON has offered to provide other confidential responses to HMP&L, but has indicated this response will not be disclosed to HMP&L. Please provide that response to HMP&L or explain why HMP&L is not entitled to that response, if it executes a confidentiality agreement.
- A-1. E.ON U.S. LLC and the Smelters object to this request for information. Henderson Municipal Power & Light ("HMPL") is not entitled to the November 5, 2007 letter requested because it contains business information of the Smelters and the E.ON Parties that is confidential and proprietary and that is not related in any way to HMPL or to any aspect of the transaction before the Commission that implicates any right or interest of HMPL. Disclosure of this information to HMPL even under a confidentiality agreement would harm and damage E.ON U.S. LLC and the Smelters and the proposed Unwind Transaction.
