ORDER

On October 24, 2007, South Hopkins Water District ("South Hopkins") filed its application for Commission approval of proposed rates for water service and non-recurring charges. The proposed rates for water service would generate additional annual revenues of \$122,425, a 14.2 percent increase in normalized test-year sales of \$862,394. The proposed rates would increase a customer's monthly bill with a 5/8" x 3/4" meter connection using 5,000 gallons from \$22 to \$25.08, a \$3.08 or 14 percent increase. The proposed non-recurring charges will produce annual revenues of \$53,860.

To review South Hopkins' application Commission Staff performed a limited financial review of South Hopkins' test-year operations. Staff summarized its findings and recommendations in a report that was issued by Order dated November 30, 2007. In its report, Staff recommended that the Commission approve South Hopkins' requested rates. On November 30, 2007, we directed for all parties to submit their comments or requests for an informal conference or hearing within 10 days. The Commission has not received any comments or requests.

The Commission, after considering the evidence of record and being otherwise sufficiently advised, finds that the rates for water service and non-recurring charges proposed by South Hopkins and shown in this Order at Appendix A are fair, just, and reasonable.

IT IS THEREFORE ORDERED that:

1. The rates for water service and non-recurring charges proposed by South Hopkins and contained in Appendix A of this Order are approved for service rendered by South Hopkins on and after the date of this Order.
2. Within 30 days of the date of this Order, South Hopkins shall file with the Commission revised tariff sheets setting out the rates approved herein.
