GENERAL EXCHANGE SERVICES TARIFF TELECOMMUNICATIONS RELAY SERVICE SURCHARGE

A. Rules and Regulations

1. Pursuant to KPSC Administrative Case No. 333 and Case No. 372, a monthly surcharge shall be imposed on all local exchange access lines to fund the Kentucky Telecommunications Relay Service. For purposes of application of this surcharge, access lines are defined as facilities which provide access to and from the telecommunications network for toll service and for local calling with the exception of Public Coin, WATS, Remote Call Forwarding, Radio Common Carriers, InterLATA Foreign Exchange Lines, Private Line Services, Mobile, Other Common Carriers and Company Official Accounts. The surcharge shall appear as a separate line item on the customer's bill and shall read "TRS/TAP Surcharge".

B. Rates and Charges

The Commission has determined the amount of the surcharge will be as follows:

However, this amount is subject to change by the Commission to meet the needs of providing Telecommunications Relay Service for the hearing and/or speech impaired persons in Kentucky.
