- 4. At any public hearing in this matter, neither opening statements nor summarization of direct testimonies shall be permitted.
- 5. The Commission does not look favorably upon motions for continuance.
 Consequently, motions for extensions of time with respect to the schedule herein shall be made in writing and will be granted only upon a showing of good cause.
