**MOTION OF LOUISVILLE GAS AND ELECTRIC COMPANY  
AND KENTUCKY UTILITIES COMPANY FOR AN EXTENSION  
OF TIME IN WHICH TO FILE DATA RESPONSES**

Louisville Gas and Electric Company (“LG&E”) and Kentucky Utilities Company (“KU”) (collectively, the “Companies”) respectfully move the Public Service Commission of Kentucky (“Commission”) to issue an order granting LG&E and KU through and until March 28, 2008, to file their responses to Commission Staff’s First Set of Data Requests and the requests for information from the Office of the Attorney General (“AG”). In support of this motion, LG&E and KU state as follows:

On February 18, 2008, the Commission issued orders establishing procedural schedules in the above-captioned proceedings. In those orders, the Commission instructed LG&E and KU to file their responses to the tendered data requests by February 28, 2008. Additional time is needed for LG&E to respond to 126 data requests (not including subparts), and for KU to respond to 123 data requests (not including subparts). In addition, the Companies’ consultant, John Spanos, will be actively assisting in responding to the tendered requests, has limited availability in the next few weeks.

The Companies have consulted with the AG, which has authorized the Companies to state that the AG agrees to the requested extension and to the revised procedural schedule set out below.

**WHEREFORE**, Louisville Gas and Electric Company and Kentucky Utilities Company respectfully request that the Commission issue an order granting the Companies through and until March 28, 2008, to file their responses to Commission Staff's First Set of Data Requests and the requests for information from the Office of the Attorney General, and revising the current procedural schedule as follows:

- Companies' responses to Staffs First Data Request and the AG's request for information shall be filed no later than..... 03/28/08
- Supplemental requests for information to Companies shall be filed no later than..... 04/14/08
- Companies' responses to supplemental requests for information shall be filed no later than..... 04/28/08
- Intervenor testimony, if any, shall be filed in verified, prepared form no later than..... 05/12/08
- Requests for information to Intervenors shall be filed no later than..... 05/26/08
- Intervenors shall file responses to requests for information no later than..... 06/09/08
