
**ATTORNEY GENERAL'S MOTION TO MODIFY PROCEDURAL  
SCHEDULE AND TO HOLD IN ABEYANCE**

Comes now the Attorney General of the Commonwealth of Kentucky, by and through his Office of Rate Intervention, and respectfully moves the Public Service Commission to suspend the procedural schedule in the above referenced matters and to hold the subject cases in abeyance until such time as the companies file their base rate cases.

In support of these motions, the Attorney General notes that, in their motions filed on June 5, 2008 in the instant matters, the companies have indicated that it is highly likely that they will file their notices of base rate cases on or around July 1<sup>st</sup>, 2008. Additionally, the companies have indicated that they intend to file motions in the instant matters simultaneously with the aforesaid notices requesting that the cases be combined in the interest of judicial economy and administrative efficiency. In light of the limited resources of his office, the

Attorney General agrees with the companies that combining the instant cases with the upcoming rate cases would promote judicial economy and administrative efficiency and, therefore, moves the Commission to suspend the procedural schedule and hold the instant matters in abeyance until such time as the companies file their notices of the base rate cases.
